The irrigation infrastructure under the Shire Valley Transformation Program - I is under construction, at the moment with focus on the intake and the first six km of the main canal. Construction of the remaining 46 km of the main canal is expected to start in June 2021. The demarcation and adjudication of about 22,500 plots with a total area of 13,260 ha has been completed by staff from the Ministry of Lands.


