Dear Council Member,

ADB as the Implementing Agency for the child project entitled: Indonesia: CTI: Coral Reef Rehabilitation and Management Program-Coral Triangle Initiative, Phase III (COREMAP-CTI III) – GEF ID 5171 under the Program Framework Document (PFD) entitled: Regional: CTI The Coral Triangle Initiative (PROGRAM) - GEF ID 3647, has submitted the attached proposed project document for CEO re-endorsement of a major amendment in accordance with ADB and GEF procedures.

The Secretariat has reviewed the project document. The amendment involves i) cancellation of the ABD loan to which the GEF grant was linked, ii) shifting the executing agency from MMAF to the Ministry of National Development and Planning (BAPPENAS), and iii) extending the project closing date to December 2022. The Government of Indonesia has confirmed that MMAF will continue to invest in coastal and marine resources management, which will offset the cancelled ADB loan, and continue to address the original project targets including 2.33 million hectares of marine protected areas under effective management as indicated in the GEF CEO Endorsement.

We consider these changes to be major amendments to the original project document endorsed on September 19, 2013, although the overall project budget has not been changed. In keeping with GEF procedures, the Secretariat has reviewed the proposed changes and has ascertained their appropriateness in light of the project's objectives.
