Implementation Status and Key Decisions



Implementation Status & Results Report Sustainable Financing for Biodiversity Conservation and Natural Resources Management (P127490)

The Sustainable Financing for Biodiversity Conservation and Natural Resource Management project (SFBCNRM) is a full-sized free standing GEF project. The primary objective of the Sustainable Financing for Biodiversity Conservation & Natural Resource Management (SFBCNRM) project is to improve the operational effectiveness and sustainability of the Bhutan Trust Fund for Environmental Conservation (BTFEC). The project also aims to enhance the transparency and competitiveness of the conservation grant program of the Trust Fund and enhance the impact of its financing on biodiversity conservation outcomes.

Important progress has been made during the first three years of the project in building and strengthening the operational effectiveness of BTFEC and in implementing a series of projects aimed at improving conservation management of forests and alpine ecosystems in the high altitude northern areas (HANAS) landscape in Bhutan including three Protected Areas (Jigme Dorji National Park (JDNP), Wangchuck Centennial National Park (WCNP) and the Bumdeling Wildlife Sanctuary (BWS)) and associated alpine meadows, forests and other ecosystems. The project has also been working to build capacity for the mainstreaming of conservation and sustainable forest and natural resource management approaches in national policies, strategies and plans.

COMPONENT I: Significant progress has been made under Component 1 in enhancing the operational effectiveness of BTFEC. In addition, at MTR the results framework indicators associated with Component 1 have either already been fully met or are on their way to being met. The following has already been achieved: preparation and operationalization of the BTFEC Bylaws; update of the Fund's Operational Manual; the development of an integrated information management system; project monitoring has been improved through the development of a new project monitoring matrix, the Monitoring and Evaluation Framework has been prepared and adopted, and guidelines for operationalizing the M&E system. are under preparation; the grant programing process has been updated and improved through the introduction of new proposal writing and reporting formats and revised screening formats used by the Technical Advisory Panel (TAP): a Fund Raising Strategy was completed and plans for implementation are under consideration; to ensure gender perspective is captured in the grant making process a Gender Equity Strategy Framework has been adopted; a review of the investment management options are currently under consideration with the BFTEC Board and Asset Management Committee; Diversification of the Board Representatives has been achieved; Strategic Plan II was implemented and the Strategic Plan III has been prepared and approved and specific plans for its execution are being developed. It was determined that the Royal Charter cannot be updated because it was signed by the King and therefore amendments are being made through adjustments to the Bylaws.

COMPONENT II: Implementation of Component 2 has been satisfactory with very good results from the ongoing and completed projects. Twelve sub-projects amounting to approximately US\$ 2.7 million have been approved by the BTFEC Board and are under implementation. The results framework indicators associated with Component 2 have all either already been achieved or are on track to achieve the end of project target. The types of activities financed include: park infrastructure to cater for better access to remote areas; establishment of community insurance schemes for livestock predation; human/wildlife conflict mitigation programs; improved livelihood support programs; ecotourism development; rehabilitation of degraded rangelands; protection of critical habitats for migratory birds; anti-poaching programs; improved monitoring and patrolling programs and systems. Three of the projects have been successfully completed. While there have been some delays in reporting and release of funds for the sub-projects in the past this issue has been resolved. Important lessons are being learned, documented and shared. One important example of this is exchange of information about the failure of a bio-briquette activity in Wangchuck Centennial National Park, which caused a similar activity proposed in Jigme Singye Wangchuck National Park to be revised using more appropriate technology.

COMPONENT III: The implementation of Component 3 has been very successful. The results framework indicators associated with Component 3 have all either already been achieved or are on track to achieve the end of project target. The first phase of mainstreaming of conservation and sustainable forest and natural resource management approaches in national policies, strategies and plans has been initiated with support for undertaking a gap analysis of conservation policy, mainstreaming management effectiveness of Bhutan's protected areas, sharing lessons and experiences from activities supported under the HANAS component, strengthening human resource capacity and adoption of a landscape approach to develop a strategic management plan for snow leopards.


