Implementation Status and Key Decisions

Mauritania Sustainable Landscape Management Project under the SAWAP (P144183)

The Mauritania Sustainable Landscape Management Project is one of twelve investments under the GEF/World Bank Sahel and West Africa Program in Support of the Great Green Wall Initiative (SAWAP). The Project became effective on December 17, 2015, and the Project Management Unit has since then taken several actions to get the project on an implementation path. A national project launch workshop was held on December 14, 2016 in Nouakchott. In the field, eleven interventions sites were selected and approved by the Pilot Committee. Three region launching workshops, respectively in Trarza, Brakna and Gorgol, were held in the period of end of 2016 and earlier in 2017. A field brigade team has been established in close collaboration with the Projet Regional D'Appui au Pastoralisme au Sahel-Mauritania (PRAPS-MR) to implement the field activities. The planting of gum Arabic trees in controlled "ecosystem regeneration" has been achieved.

Numerous activities in the field have started in 37 sites out 49 by end of December 2017, however many of them were to mobilize the communities and to undertake community participatory diagnostic activities to come to precise activities which will regenerate gum arabic producing ecosystems in controlled areas as well as support local needs which will lead to reduced pressure on natural resources in the regions. So even though the above indicators do not show progress the reality in the field is positively different. If the project would not be so specifically designed to allow for the community participation in decision making of course the completion of the above indicators could have started faster but that would have been at the expense of sustainability of the activities
