Implementation Status and Key Decisions

The Project was approved by the World Bank on July 6, 2017 and became effective on Feb 6, 2018. Reforestation activities, which will lead to improved forest cover, increased carbon sequestration and more livelihood opportunities, have started in both states. Capacity building and training on biodiversity monitoring protocols and carbon measurements have been organized to improve biodiversity monitoring and eventual biodiversity management. Livelihood support activities have started and will increasingly focus on non-timber forest produce (NTFPs) to help improve participant livelihoods. The socio-economic survey of a sample of the target villages in both states has been completed and the beneficiary baselines are being



finalized by the Indian Council for Forestry Research and Education (ICFRE). These surveys will enable the assessment of socio-economic benefits provided by the project. Scaling up of Sustainable Land and Ecosystem Management (SLEM) best practices are yet to begin activities are being identified to improve the environment while helping participating communities. The second meeting of the Project Steering Committee, chaired by the Additional Secretary of the Ministry of Environment, Forest and Climate Change (MOEFCC), is planned to be held before May 15, 2019, and will approve the Annual Plan of Operations for both States and ICFRE.

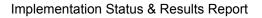


