**Implementation Status and Key Decisions****Madagascar**

The financial realization of the project is 19% instead of 33% as foreseen initially. The activity completion rate is estimated at 34%. Despite the restrictions related to Covid19, the implementation of project activities has improved for the year 2020, and is continuing the trend for the first trimester of 2021, compared to previous years. Weaknesses in the planning and sequencing of activities remain significant and the implementation rate of Annual Work Plan and Budget 2020 remains low. However, a number of large procurement activities have been prepared and there are



currently up to \$5 million in commitments with a number of other contracts in procurement. These activities should steadily increase disbursement over the next quarters.

The implementation of the web based Open Artfish program in Diana, Analanjirofo and Melaky is well under way. The introduction of Open Artfish in five new regions, outside the ZUPs, is planned, but could not be started yet due to the health crisis. The first branch of the Fisheries Monitoring Center in Nosy Be has been officially opened during the reporting period which allows the deployment of the FMC to the first Ultra-Priority Area. Around 4000 safety kits were distributed to fishermen and a number of studies have been starting including on new procedures of small-scale vessels registration, valorization & marketing of fisheries products, as well as a number of technical studies for infrastructures. The National Aquaculture Development Strategy has been developed and validated. The new decree related to the shrimp fisheries has been adopted. The constructions of 3 administrative buildings is currently ongoing.

#### **Key decisions:**

After the finalisation of mid term review, a restructuring of the project will be completed to strengthen the alignment of the project with the Madagascar Emergence Plan, to increase the impact of the project while simplifying its implementation, and to contribute to the development of a Blue Economy in Madagascar. The restructuring process can now start after pending while waiting for the review of MCS related indicators as well as the final report of the mid-term review.

In addition, new activities which can be packaged is been considered to be integrated in the project to improve its impact in sector such as support in terms of infrastructure to the Lobster Research Unit and the Mahajanga Fisheries Products Distribution Center.

Besides, the projects indicators and the targets will be revised during the restructuring process to reflect the real needs of the sector and ensure that the indicators can be track down, namely the number of legal text adopted by the Ministry in charge of Fisheries, Small-scale fishing units in the priority areas using prohibited gear observed during on-shore inspections and the Small-scale fishing units inspected annually on-shore.

#### **Offgrid electrification - PHRD Grant**

The off-grid electrification plans for the 20 villages are finalized. The technical studies and inspections of PHRD infrastructures are being prepared. The equipment related to these infrastructures are being ordered.

#### **IOC**

Activities have been slowed down by the Covid19 crisis and travel restrictions especially since quite a lot of the activities required travelling and organisation of meetings. With the pandemic, a fallback of the countries on themselves was observed, preferring to focus on their national response and recoveries rather than on regional activities. This impacted several of the regional activities and components.

#### **IOTC Component:**

- A number of consultancies that were on hold due to Covid19, resumed are advancing.
- The long term MCS expert has been hired and started his assignment in Seychelles within the IOTC compliance section to support SWIOFC countries in improving their compliance with IOTC Conservation and Management Measures.
- The preparation of the IOTC Conservation Management Measures training package is ongoing
- The development of eMaris and a mobile application for ePSM, are progressing. These will provided tools for IOTC members countries to improve their compliance with the IOTC Conservation and Management Measures.

#### **AIODIS Component**

- Three important AIODIS consultancies were largely impacted by the restrictions linked to the Covid19 pandemic. In order to advance the activities, local consultants were hired to assist international consultants who could not travel to the field. the studies have been finalised and are in a validation process. This includes:
  1. Preparation for pledge, sensitization and communication to Authorities, private sector and NSAs
  2. Identification of existing initiatives, lessons as well as bottlenecks for the emergence of young entrepreneurs in favour of circular economy
  3. Intellectual Property rights issues related to innovative projects in the field of circular economy
- No high level meetings could be organised in 2020 and prizes of the best entrepreneur and best proposal of the 2019 Blue Champion Award winners (December 2019), had to be redefined. The prizes was initially supporting participation of the winners in relevant workshops abroad, but were revised and the project will cover patenting procedure costs for the project proposal award winner, and short course fees and marketing costs will be supported for the best entrepreneur award.

#### **FPAOI Component**

- Under the FPAOI component of the project, most activities requiring physical workshops, conferences and meeting have been postponed to 2021. However, some of the statutory meetings of the FPAOI were held remotely and a consultant was hired to review the action plan under this component to better support the federation.
- National Workshops on the Development of a Strategy for Small-scale Fisheries were held in Rodrigues and Comoros in September 2020 to discuss ways and means for a sustainable development of small-scale fishing with the active participation of local fishermen. These should feed a regional strategy for small-scale fisheries in the Indian Ocean.
- Currently, an assessment is ongoing on the activities of the FPAOI and some recommendations will be made to increase the impacts under this component.

The mid-term evaluation of the regional activities is currently being finalised and the recommendations will be taken forward once finished.


