I. INTRODUCTION

A. Background & Purpose of Report

- 1. The Port Vila Urban Development Project (PVUDP) under the ADB Loan: 2832-Van (SF)/G0275-Van/Go276-Van, commenced in February 2013. The Ministry of Finance and Economic Management (MFEM) is the project executing agency (EA). The Public Works Department (PWD) under the Ministry of Infrastructure and Public Utilities (MIPU) and the Department of Environmental Protection and Conservation (DEPC) are the key implementing agencies (IA). Project management is being delivered by the Vanuatu Project Management Unit (VPMU) assisted by the Design Supervision and Capacity Development (DSCD) consultant, Roughton International in association with Qualao Consulting Ltd (RI).
- 2. The DSCD was established in the latter part of 2013 and also consists of Gender & Community Participation Specialist (GCPS), Community Liaison Officer (CLO), an International Environmental Specialist (IES), National environmental Specialist (NES) and an International Resettlement Specialist (IRS).
- 3. Specifically, the Project Administration Manual (PAM) outlines under Safeguards Monitoring and Reporting that: "The Borrower shall do the following or cause the Project Executing Agency to do the following:
 - Submit semi-annually Safeguards Monitoring Reports to ADB and disclose relevant information from such reports to affected persons promptly upon submission;
 - If any unanticipated environmental and/or social risks and impacts arise during construction, implementation or operation of the Project that were not considered in the IEE, the resettlement plan or the indigenous people's plan, promptly inform ADB of the occurrence of such risks or impacts, with detailed description of the events and proposed corrective action plan; and
 - Report any actual or potential breach of compliance with the measures and requirements set forth in the EMP, the resettlement plan or the indigenous people's plan promptly after becoming aware of the breach.
- 4. This report is the fifth semi-annual Environmental and Social Safeguards Monitoring Report prepared for the PVUDP. The overall safeguards requirements are set out in a number of documents including laws of Vanuatu (including any conditions on permits issued), the loan agreement, initial environmental examination (IEE).
- 5. A monthly environmental monitoring report of each sub-project is being provided by the DSCD IES and NES to the VPMU Safeguards Team. A quarterly social safeguards monitoring report is also provided by the GCPS to VPMU Safeguards Team. VPMU will then submit a semi-annual report to the government and ADB as part of its monitoring commitment under the project.
- 6. Since early August 2017 the ESMO role within VPMU has been vacant following the resignation of the incumbent officer. At the time of writing this report a replacement ESMO had not yet been appointed by VPMU. Since August 2017 the ESMO tasks have been undertaken by environmental consultants

(one international and one national) appointed in June 2017 to support the ESMO through a Grant funded under the Vanuatu Interisland Shipping Support Project. (See section V).

B. Description of the Project

7. The Port Vila Urban Development Project has been established to contribute to the sustainable urban development of Port Vila. The Project outcome will be the improvement of the infrastructure for Port Vila and the improvement of the mechanisms which are to assist the Government to efficiently manage its infrastructure. The outcome will be realized through the following Project outputs;

Output 1	:	The Government has improved the road network and drainage system in greater Port Vila.
Output 2	:	The Government has improved the sanitation system in greater Port Vila.
Output 3	:	Central area and settlement communities use improved hygiene facilities.
Output 4	:	Government agencies and community user organizations have the capacity to effectively and efficiently manage sanitation, roads, and drainage systems
Output 5	:	Efficient project management services will be provided.

- 8. The project is classified as category B for environment and category B for involuntary resettlement. Social and environmental safeguards due diligence following SPS and country safeguard systems has been completed and approved by the government and ADB.
- 9. The PVUDP comprises of the following sub-projects for civil works, as presented in the tables below;

C. Compliance With Statutory Requirements

- 10. The PVUDP has adopted and complied with relevant in-country and donor safeguard requirements, within this reporting period, and which are applicable to all the sub-projects, namely the George Kalsakau Drive and Concourse, Roads and Drainage, Septage Treatment Facility, Community Sanitation Facilities and Community Engagement Facilities. Refer to Annex C for list of statutory requirements.
- 11. Within this reporting period, there has been one instance where the works and activities of Contractors has been in breach of the identified legislation and regulations (refer to Table 4 -Urban Roads and Drainage Phase 1 subproject disposal of construction waste in an unauthorised location). This issue has not been properly addressed by the Contractor. Whilst there have been no sanctions or penalties made against the Contractor to date, VPMU is currently considering such action. A number of environmental/community safety issues have also been identified and raised with the Contractor for corrective action and/or explanation.

II MONITORING ACTIVITIES AND STATUS OF SAFEGUARDS COMPLIANCE DURING REPORTING PERIOD

Monitoring of environment and social safeguard activities was conducted by the DSCD through the following methods:

- 1. Spot checks
- 2. Baseline (benchmarking) of important conditions
- 3. Site visits
- 4. Inspection of the works, using CEMP compliance checklists

Typically, monitoring consisted of a weekly joint site inspection with the contractor DSCD environment specialist and DSCD contracts manager using a checklist based on the approved CEMP for each subproject. Minor environmental issues were addressed on site with the contractor and more significant issues followed up after the inspection by a letter from the DSCD to the contractor. Contractor's environmental checklists are normally provided to the DSCD team after site inspections, although during this reporting period the Contractor frequently did not provide his monitoring checklists to the DSCD

For each of the five subprojects VPMU reviewed the various safeguards monitoring reports prepared by the DSCD's safeguards team. These reports include:

- 1. Gender reporting quarterly reports plus the annual GAP progress report in the updated format
- 2. Environmental reporting through the monthly checklist reports
- 3. UR&D access and consultation items captured in the DSCD weekly report.
- 4. UR&D safeguards issues captured in HELP DESK, particularly disputes and grievances
- 5. Community Liaison Committee meetings reported through circulated minutes

The tables below summarize the status of environmental and social compliance issues for each subproject during the reporting period as identified in the reports above.

III. GRIEVANCE REDRESS ISSUES


No grievance redress issues arose during the reporting period.

IV. STAKEHOLDER CONSULTATIONS

DSCD developed a communications strategy, which is implemented to ensure that the general public, government departments and the private sector are fully aware of the project objectives and progress against outcomes. Key activities being implemented within the strategy include; newsletters and two public notice boards. A newsletter has not been produced since February 2018. VPMU are the point of contact with the media and implement a radio program and engagement with the news media.

In February the DSCD team undertook consultations with a number of stakeholders regarding the location and operation of the temporary asphalt plant at the Ex- MCI Quarry site. Those consulted include Assistant community chief of Nikinepen Community, Chief of Tekapu II Community and Mr John Tanner of South Seas Shipping Co. Those consulted advised that they had no objection to the location and operation of the asphalt plant and requested that further information on the operation in terms of timing etc be advised to the communities nearer the time of operation.

Traffic Awareness Consultant (TAC) was recruited in Q4 2017 to improve and broaden the reach of the UR&D PH1 traffic awareness campaign. A detailed plan and budget was developed for implementation in Q1&2 2018. The campaign was put on-hold in Q2 2018 but is likely to be re-started in Q3 2018.



Infrastructure and priorities change for Stade intersection were originally planned for implementation in March 2018, as agreed by the contractor RMS. DSCD developed an information handout in 3 languages which was distributed through:

- a) OGCIO network of 3000+ employees
- b) Design and traffic notice printed in the Daily Post
- c) Email network of 450+ direct recipients
- d) VCCI e-distribution

The contractor did not implement the changes for Stade Intersection in March and the substantial works for the intersection were completed in June 2018.

A Traffic Management Task Force was established by VPMU in July 2017. Q1 2018 Task Force meeting (involved 7 males and 3 females).

In 2017 VPMU and Police agreed to finalize and sign an MOU to formalize support and protection for traffic controllers. DSCD are still awaiting the signing of the MOU between Police and VPMU.

V. INSTITUTIONAL STRENGTHENING AND TRAINING

ADB commenced provision of environmental safeguards support to PVUDP (and other VPMU projects) through a Grant funded under the Vanuatu Interisland Shipping Support Project (VISSP). Under the Grant an international environmental specialist (IES) and a national environment specialist (NES) were engaged by VPMU in June 2017 for 7 months and 12 months input over 14 months respectively. The purpose of the assignment is specifically to build capacity in implementation of environmental safeguards within VPMU and the various projects under its purview.

During the reporting period VPMU's IES supported the PVUDP environmental team in the following activities:

- Provided support to VPMU in following up on key findings of PVUDP Water Quality
 Monitoring Final Report (WQMFR) and assisted National Project Manager in initiating
 WQMFR priority recommendations for actions among relevant government stakeholders
 (DEPC, DoWR PVMC).
- Provided advice to PVUDP env safeguards team in responding to environmental non compliances eg) unapproved change in spoil dump site by contractor and associated noncompliance with fill placement method
- Supported PVUDP env safeguards team in stakeholder consultations in respect of site for Asphalt plant as well as obtaining PEA.
- Provided ongoing support to PVUDP environmental team in streamlining new monitoring procedures.
- Participated in meetings to address community grievances regarding projects eg) PVUDP Asphalt Plant location,
- Mentoring VPMU national environment specialist in undertaking site inspections and reporting on environmental compliance of contractors.
- Ongoing coordination with VPMU technical staff on safeguard issues and development partner safeguards requirements including procedures and process.
- Participation in progress meetings to report and obtain information on safeguards issues
 including advice on problem solving as required and safeguards requirements in general.
 This has provided the opportunity for the VPMU safeguards team to raise awareness of

- environmental issues with technical teams on current issues as well as identifying potential future issues with an opportunity to find proactive solutions.
- Sharing of examples of good practice and lessons learned across all VPMU project implementation stakeholders (VPMU staff & consultants, PITs and Contractors)
- Assisted VPMU identify and procure a water quality monitoring specialist to formulate and implement a plan for long term monitoring of potential surface and ground water impacts of the operation of PVUDP's STF.
- Reviewed various safeguards reports prepared by PIT and provided comments as needed.

VI. SUMMARY AND CONCLUSIONS

Overall, there has been continued environmental compliance by the Contractor. That being said, a significant breach in contract conditions by the Contractor remains unresolved in respect of the unauthorized dumping of spoil at the VIT site. This includes i) no permit for the development of the site including placement of fill, ii) no provision in the contract for spoil disposal at sites other than Bouffa landfill, iii) irregularities in the Contractors land use agreement with VIT and iv) disposal methodology does not comply with specified contract requirements for embankments. VPMU is supporting DSCD in enforcing contractual requirements in respect of this issue.

In late 2017 VPMU initiated an action plan with concerned government agencies following the WQMP Final report's findings and recommendations related to the widespread detection in the harbor of bacteria concentrations of concern. In February 2018 DEPC took over responsibility from VPMU formulating and implementing an action plan following on from the results of the water quality monitoring undertaken in Dec 2017. VPMU continues to be represented in the interagency working group responsible for implementing the action plan.

VPMU have been assisting ADB in formulating a plan for long term monitoring of potential ground and surface water impacts of the operation of the STF. A water quality monitoring specialist was identified who subsequently prepared a proposal for the work. The proposal is currently under review by VPMU and ADB.

Monitoring of social safeguards issues including implementation of the GAP by the DSCD social safeguards team has been robust throughout the reporting period. A separate independent GAP has been prepared for further reference. Key achievements include:

- a) Consultation Informs Design: Extensive consultation with key stakeholders has ensured that the voice of women, as well as men, has informed every step of project development; from site selection for community and public sanitation facilities to the initial design and subsequent revision of designs for both CSF and PSF. Persons living with disability have played a key role in sight inspections to ensure that facilities are fully accessible.
- b) **Maximising Women's Employment:** Overall employment under the project has seen 19% women's employment. There have been 125 men and 30 women employed under 6 construction contracts todate on the project, which represents an overall number of 20% women's employment.

- c) **HIV Awareness:** All 5 construction contractors have complied with their responsibility to conduct HIV awareness through an authorised provider. To-date HIV awareness under the project has reached 531 men and 463 women including contractor personnel, community members and the general public.
- d) **Hygiene & Sanitation Awareness and Education:** The project has actively engaged with 7 target communities consistently over the last 4 years with an overall education and awareness program reach to date (31 June 2018) of 2960 women, 1846 men, 3181 girls and 3265 boys. Solid waste management has been greatly improved in all target communities with sanitation committees collecting and removing 32 truckloads of oversize solid waste from the communities during the reporting period.

Key challenges include: i) incidents of physical and verbal abuse of female traffic controllers in respect of Output 1 and ii) Serious social safeguards issues with regard to the CSF contractor, David's Construction namely. noncompliance with the labour laws of Vanuatu or the VNPF Act. Evidence suggests that the Contractor paid employees less than minimum wage and failed to provide employees with employment contracts. Available data indicates that the Contractor failed to fully comply with VNPF registration and may have underpaid VNPF contributions by as much as 33%. iii) Outstanding serious defects in the CSFs following practical completion of works.

Actions proposed/undertaken to address these issues include: issue i) DSCD has recommended that a Memorandum of Understanding between police and VPMU be drafted in regard to systematic protocols for traffic control incidents: Issue ii) It was recommended in the post contract review the Government of Vanuatu should not engage David's Construction in any future development projects. Issue iii) A defects rectification briefing note was submitted on 22 Jan 2018 which presented four options: 1 – terminate the Contractor's contract and utilize the retention monies to engage another contractor to rectify the defects in total; 2 – terminate the Contractor's contract and utilize the retention monies to engage another contractor to rectify the defects in the most practical and cost-effective manner, for example re-plumbing the work rather than replacing the existing within walls and floors; 3 – require the Contractor to rectify the defects by engaging a registered tradesman at his cost to ensure that proper trade standards and practices are achieved – tradesman to be approved by the Project Manager; and 4 – require the Contractor to rectify the defects. At the end of the reporting period (30 June 2018) no decision had been taken regarding the four options outlined above.

APPENDIX A: Details of Sanitation and Hygiene Awareness and Education Program Undertaken during Reporting Period

A. January – March 2018

- The project continues to provide capacity building support, training and education to 7 target communities through the Community Support and Training Officer (CSTO), a role which was established as part of the DSCD team in October 2016. The CSTO works closely with the 10 sanitation committees (SCs) as well as with the wider community. Key achievements and consultations for Q1 2018 are summarised below;
- 2. Membership in the SCs sits at 70 women and 44 men serving in 10 committees.
- 3. CSTO supported the SCs financial management and roles and responsibilities training involving 93 women and 60 men in this first quarter of 2018. All but 1 of the SCs are now providing quarterly reports to the wider community. In 2 communities there have been accusations of misuse of funds by leaders and DSCD continue to support discussions and finance training in an attempt to improve financial controls for the SCs.
- 4. Anecdotal reports from committee members reflect that they are seeing improved hygiene among both children and adults. Children are "fighting over showers in the evenings" as they are now enjoying taking their evening shower. The two communities which are still undergoing construction of community engagement facilities report that "its rare to see people washing their hands after using the bush toilet because of the lack of water tubs near the bush toilets".
- 5. While personal hygiene and solid waste management have improved, observation of the sanitation facilities show that committees are struggling to keep the facilities to a high standard of cleanliness. However, the current standard is still a significant improvement from the pre-project hygiene standard.
- 6. Hygiene and sanitation awareness movie nights were a big success in all 7 target communities this quarter with 285 women and girls and 220 men and boys in attendance. Movie nights provide a great opportunity for the sanitation committee to engage with the wider community to discuss the importance of financial support of the facility, good hand washing and personal hygiene and solid waste management.
- 7. Overall sanitation and hygiene education program reach to date:
 - The overall sanitation and hygiene program reach to date (31 March 2018) is 2847 women, 1777 men, 3154 girls and 3230 boys.

B. April - June 2018

- The project continues to provide capacity building support, training and education to 7 target communities through the Community Support and Training Officer (CSTO), a role which was established as part of the DSCD team in October 2016. The CSTO works closely with the 10 sanitation committees (SCs) as well as with the wider community. Key achievements and consultations for Q2 2018 are summarised below;
- CSTO supported Sanitation Committees (SCs) in financial management and all but 1 of the committees
 presented a quarter 1 finance report to the wider community. All SCs are collecting either weekly or
 monthly contributions to operation and maintenance costs from facility users.
- 3. Sanitation Committees are beginning to tackle both minor and major maintenance issues, with Seaside Paama having replaced stolen shower heads. Seaside Tongoa building 2 was experiencing overflow of waste water running down the hill towards their community hall. The community plumber discovered that the sewer pipes were running to the old, defunct septic and had not been piped to the newly constructed septic. This installation defect was corrected by the community. Shower push-taps, which were installed but did not meet the specifications, have begun to fail, with water running from the shower head continuously. The community has, in some instance, installed a second tap at the shower head and in another they have broken the tile work to remove the push tap and install and simple garden tap handle.
- 4. The Sanitation Committees have been equipped with a desk and chair, lockable cash box, calculator and financial reporting templates. SCs have also received cleaning equipment, rubber boots, garden hose, rubber gloves, etc. Initial supplies of cleaning products have not been replaced in some communities, while others are continuing to purchase industrial cleaning products.
- 5. CSTO led another large-scale removal of solid-waste in the target communities, in preparation for the Klin Komuniti Kontest, which was cancelled on instruction from VPMU. However, there were 32 truck-loads of over-size solid waste hauled from target communities to the dump at Bouffa. Communities are visibly cleaner and all have planted flowers around the facilities to further beautify areas, which were formerly very poorly maintained and unsanitary. The significant reduction in solid waste is expected to reduce rates of dengue as well as rat and cockroach borne illnesses.
- 6. Overall sanitation and hygiene education program reach to date:
 - The overall sanitation and hygiene program reach to date (31 June 2018) is 2960 women, 1846 men, 3181 girls and 3265 boys.
