Implementation Status and Key Decisions

This ISR covers the initial project in Mauritania and in Guinea (P126773) that became effective in 2015 and its GEF additional financing in Guinea, Liberia and Sierra Leone (P156759) that became effective in 2017. Project status and key messages are based on the Mid Term Review (MTR) missions in Mauritania (March 21-30, 2018) and in Guinea (March 31- April 12), as well as regular implementation support missions in Liberia (March 21-28) and in Sierra Leone (May29 - June1). Respective Aide Memoires are all publically available.

Overall, the project is rated Moderately Satisfactory due to implementation delays, in particular, the civil works under component 3 in both countries.



The remaining indicators are the list of artisanal fishing boats (annually) and fees collected under fishing agreements (annually) for next years.

Mauritania did not achieve the target for this year, publishing only 2 indicators, 1) list of infractions in industrial segment (monthly) and 2) fees from infractions (annually).

The Guinea government issued a new Decree in December 29, 2017 to have three categories of artisanal canoes, 1) Traditional artisanal canoe, 2) Motorized artisanal canoe, 3) Advanced artisanal canoe. If the government decides, the project may include another category of a ceiling for Advanced artisanal canoe (or PAA, pêche artisanal avancé in French). This will be confirmed during an upcoming restructuring.




