### Implementation Status and Key Decisions

The project has made progress over the period November 2021 - April 2022, despite the impacts of the COVID-19 pandemic and suspension of disbursements due to the Government's lapsed loans.

- Component 1 "Support to the implementation of the National Ivory Action Plan (NIAP)": the launch workshop on the national natural resources database, including on elephant populations, was finalized. Training for stakeholders in the use of the National Database was successfully conducted and exceeded the target.



Component 2 "Support for integrated landscape management and local community participation": the elephant corridor protection plan has been developed and validated and is currently under implementation. The Local Management Consultative Committees executive office in Moukalaba-doudou park has been renewed to ensure continued awareness-raising campaigns on sustainable parks management for local communities.
 Component 3 "Border Surveillance" against the intrusions of poachers on Gabonese territory has been intensified thanks to the construction of the Mourindi electric fence in the Moukalaba-doudou park in August 2021 and the construction of the surveillance antenna of Doussala is still underway.


