## Implementation Status and Key Decisions

**Project Implementation arrangements are operational.** Since the last ISR, the Bank team and the Regional Implementation Support Unit (RISU) had country-specific implementation support missions for each of the six countries, as well as one with the regional entities. Despite the COVID situations, hybrid and/or in-person missions were conducted. An operational reporting and support mechanisms with the regional institutions is in



effect including a regional steering committee attended by the six engaged countries and networks of specialists from the six countries. For instance, the 7th regional steering committee took place in November 2021. Progress reports with performance indicators are compiled every six months based on national progress report from each country. Safeguards progress reports are prepared and consolidated every three months. The organizational effectiveness of Project Implementation Units is supported with capacity building by RISU and the Bank team as needed. Staff turnover is still being experienced in some PIUs, but solutions and re-adjustments are done as follow up to implementation support missions.

**Regional Integration is showing progress:** The arrangement with IUCN managing a Regional Implementation Support Unit (RISU) and with WAEMU managing a Regional Management Unit are being implemented with already observed improvement related to implementation times. The arrangement is ensuring effective regional coordination and integration across country activities. Nevertheless, increased coordination, preparation and speed for the financial transfers as well as audit reports and financial management are still needed on financial management aspects. Also, the achievement of concrete results in the coming months is essential to confirm the effectiveness of regional integration for building coastal resilience. WAEMU is planning the organization of a Regional Minister's Meeting in February 2022 with the objective to; (i) validate the 2020 State of the West African Coast, (ii) validate practical arrangements for setting-up the Regional Observatory of the West African Coast (ORLOA) and; (iii) adopt draft regulations for the incorporation of the Abidjan Convention Protocols in WAEMU legal corpus. The Regional Partnership for Coastal and Marine Conservation in West Africa (PRCM) will organize a Regional Forum in March 2022, in collaboration with the regional institutions and networks. The RISU staffing was enhanced by the recruitment of a social development/gender specialist.

**Civil works and social sub-projects have advanced.** Despite some significant delays in the preparation of the final coastal engineering designs, the Project is progressively moving to the construction stage. Contracts for civil works for coastal protection has advanced with several signed, and major progress on coastal rehabilitation work is to be expected in 2022 and 2023. In Benin and Togo, the firm in charge of works for the transboundary coastal protection works has been recruited and Environmental and Social Impact assessment and Resettlement Action Plan have been validated and published. In Mauritania, the company for the civil work for the *colmatage* of three *breches* in Nouakchott, to protect against the risk of submersion of the capital, has been recruited. In São Tome & Príncipe, the works for safer expansion areas have been completed in one of the areas (Santa Catarina). For Côte d'Ivoire (Grand Lahou) and Senegal (Corniches de Dakar and Ile de Gorée), the project design documents have been validated and next step is the finalization of Environmental and social studies. Social sub-projects are implemented in all six countries. A mid-term review is planned for 2022 allowing for adjustments in project implementation approaches and management.

**Response to the COVID-19 situation.** To respond to the COVID-19 situation, contingencies plans to respond to COVID-19 situation are still in place within the PIUs. Technical studies continued, as most is desk top work and can be done remotely, and consultations with targeted communities, especially for social sub-projects have been limited to more but smaller groups and will remain as such until the situation is back to normal. In the meantime, the World Bank team and regional partners continue to provide implementation support through regular virtual meetings and missions.

### Overall Comments

The indicators on exposure reductions will significantly improve after the conclusion of the major protection works. The progress reported so far is thanks to small-scale (São Tome and Principe), or emergency works (Benin and Togo), which provided needed support for part of the beneficiaries, but the major contributions to those indicators will come from the completion of main contract works.

The first survey of satisfied beneficiaries is performed as part of the Mid-term review process, so the first values will be uploaded in the next ISR.


