**On exceptional basis, GEF Agencies can request a higher PPG amount with justification. The higher PPG amount in Burkina Faso is based on bottom-up cost estimates for a PPG team of international and national consultants to develop the CEO Endorsement Request. These cost estimates, itemized by consultant, are set out below, totaling USD 83,684. As this is higher than the requested PPG of USD 80,000, these additional costs above USD 80,000 will be absorbed from other non GEF sources. Of note, PPG team costs are higher to account for providing adequate security to team on the ground when carrying out technical studies and design work. In addition, because of security concerns, recruiting**

specialists to carryout work in Burkina Faso consists of a smaller pool of technical specialists who have taken security concerns into account in their daily rates.
