We regret that the implementation period of 36 months that was entered into the GEF portal at PIF stage was not correct, nor was this consistent with the envisaged five-year (60 month) implementation period that was included in the World Bank concept stage Project Identification Note (PIN) created in the World Bank portal. Five years is the standard World Bank project implementation period, and we believe that this full period is required to carry out the activities proposed under the project and achieve the PDO. We tried to edit the implementation period in the GEF portal, but this is not an editable field in the CEO ER.

## Agency Response WB 4/18/23:

- 1. The number of project beneficiaries is calculated as 30 sub-projects under sub-component 2.3 each with 100 beneficiaries. It is estimated that the number of people from civil society organizations and community groups that will participate in the small grants program sub-component of the project will conservatively be 3,000 individual direct beneficiaries (of which half are female).
- 2. The Small Grants Program (Subcomponent 2.4) will finance small sized (not more than \$30K each) innovative models for community management of shared resources under different biophysical and geographic conditions. These demonstration investments will include an initial set of no-regrets initiatives (for example mangrove restoration and the refurbishment of small-scale eco-tourism infrastructure) to stimulate job creation and revenue generation while the TDA and SAP are being finalized. The SGP will be designed during year 1 of project implementation while CCAD prepares the TDA. At the Bank's Decision Meeting, the team agreed not to attach specific indicator targets to the small grants given their intended flexibility and responsiveness to the needs of the. Based on the above, the team does not feel comfortable quantifying targets of activities that will be driven by the needs articulated by beneficiaries.

## Agency Response WB 4/18/23:

- 1. The PACA will promote ecosystem-based management by strengthening regional governance over an area of coastal and marine habitats covering almost 2 million km2, more than 600 times the area of the Gulf of Fonseca. While PACA will provide a regional approach for the large marine ecosystem stretching from Mexico to Ecuador, the Gulf of Fonseca project will develop a subregional approach with watershed-level specificity in Honduras, Nicaragua and El Salvador. SICA?s Secretary General will be part of the PACA project board, allowing CCAD to ensure that the TDA and SAP for the Gulf of Fonseca take into account the analysis and recommendations developed under the PACA for the broader Pacific Central American Large Marine Ecosystem. This is addressed in para 17 of the Project paper.

- 3. As explained above, the process of developing the TDA will include identifying, quantifying, and setting priorities for managing transboundary environmental challenges. As noted in the project paper, identified challenges include overfishing, mangrove degradation, pollution, and sedimentation, all of which may be compounded by climate variability and change. Other environmental challenges may be identified and responses to them prioritized through the TDA process.
- **4.** The small grants will pilot no-regrets initiatives (for example mangrove restoration and the refurbishment of small-scale eco-tourism infrastructure) to stimulate job creation and revenue

generation. The principal categories of activities to be supported by the small grants program include: (i) reforestation through mangrove restoration, agroforestry and silvopastoral systems; (ii) integrated landscape management practices in Gulf of Fonseca watersheds targeting soil and water conservation; (iii) waste and pollution management in Gulf of Fonseca watersheds; (iv) sustainable fishing and aquaculture activities with a focus on strengthening value chains; and (v) community-scale investments in nature-based tourism. Awards under the small grants program will not exceed US\$ 30,000, with criteria for the grants based on: (i) impact of the investment on improved management of coastal resources; (ii) readiness of the grantee to receive and manage grants; (iii) potential of the grant to leverage co-financing for the proposed initiative, including from the private sector; (iv) environmental, social and economic sustainability of the proposed activity; (v) replicability and scalability of the investment; (vi) social impact on community enhancement, job creation, gender equality, and the inclusion of Indigenous People. Decisions on investment award selection will be made transparently with key stakeholders as indicated in the Stakeholder Engagement Plan (SEP) for the project. As explained above, the topic of whether the project could meaningfully establish targets against GEF core indicators related to land restoration and terrestrial and marine biodiversity conservation was discussed at the project's Decision Meeting and it was agreed among the team and management not to establish core indicator targets given both the small contributions to be made by the small grants (averaging \$30K/project) and the intended flexibility of the SGP to respond to the demands articulated by beneficiaries. We maintain that the primary objective of the project is to deliver the TDA and SAP and establish the institutional framework for SAP implementation going forward. While it is expected that the project will influence investment through the co-financing, the co-financed activities are not managed by and therefore can not be included in the results framework of the World Bank project.

The SAP will establish priorities for action (e.g., policy, legal, institutional reforms, investments) to resolve the priority transboundary problems identified in the TDA. It will be prepared using a highly cooperative and collaborative process among the riparian countries to identify investments and management approaches, which may include inter alia (i) enhanced and/or expanded protection of key natural resources, (ii) measures to address coastal degradation and erosion; (iii) strengthened management of the Gulf?s protected areas; (iv) planning to take into account

sea-level rise scenarios; (v) methodologies for the analysis of the cost of environmental degradation; (vi) watershed management of rivers that flow into the Gulf; (vii) incentives for private sector investment in the Gulf; (viii) incentives for Payment for Environmental Services (PES). The SAP will be prepared with the integrative approach, "from the basin to the sea," to guarantee the articulation of the terrestrial and coastal marine landscape where the blue economy of the Gulf of Fonseca will be developed. The SAP will also include an estimate of the financial resources required for its implementation (including for Monitoring and Evaluation), as well as an estimate of the climate co-benefits of the proposed investments. The SAP will be a negotiated policy document that will be submitted for endorsement at the ministerial level of the three riparian countries.

The SAP will reflect agreed long-term environmental goals are achieved in a series of pragmatic action-based steps, agreed achievement indicators, and measures for making substantive progress toward resolving the long-term problems identified in the TDA. The SAP will reflect the solutions agreed to concerning transboundary issues identified with actions at regional, national and sub-national levels. The SAP will distinguish between the payment of incremental costs for those actions of purely national interest (baseline actions), government commitments and secured partnerships with donors.

2. The small grants program will pilot blue economy-based job creation in coastal areas, providing lessons and experience for subsequent scaled-up investments for which development partners in the region are ready to mobilize additional resources in support to the Economic Development of the Gulf. Through the technical assistance financed by PROBLUE, the World Bank will further consolidate the dialogue with key government agencies on how the region will benefit from sustainable management of the Gulf?s coastal resources.
