Project Design and Financing

1. If there are any changes from that presented in the PIF, have justifications been provided?

Secretariat comment at CEO Endorsement Request

The CEO Endorsement request elaborated on what was presented at PIF. One major change is the choice for the IADB to execute the project in addition to implement it. This has not been sufficiently justified.

Per the GEF guidelines, the Fee Policy explicitly precludes the merging or crossing over of the implementing functions of the GEF Agencies and the execution functions undertaken by EAs. In exceptional cases and as per the request of the beneficiary country, GEF Agencies may carry out both functions. This request must be submitted in the form of a letter by the GEF OFP that outlines the request to IADB to carry out certain execution functions, specifying which functions, why and for how much.

The GEF Secretariat then assesses this request.

10/18/2019: Thank you for submitting the referenced letter. While we understand the challenges notes, we would like to avoid the potential conflict of interest arising from using the same agency to carry out implementing and execution functions and hope another solution can be found/ Have all potential third-party entities been considered? What is the timeline for the reorganization of the fund?

10/22/2020: We appreciate the efforts made to ensure the execution of this project is carried out by the Mexican government. This comment is cleared.

An official letter dated August 29, 2019, signed by the Ministry of Public Finance and Public Credit (SHCP), as GEF Operational Focal Point, has been sent, in accordance with GEF guidelines and based on the specific comments received (Attached in RoadMap/Documents as "GEF OFP Letter- Request IDB execution functions").

In the letter, the reasoning of the decision for the IDB to perform the executing functions of the project is explained in detail. First, it explains the current limitations for SEMARNAT to carry out the execution functions of the project. Similarly, it mentions and assesses all possibilities allowed by the budgetary legislation, and the reasons for discarding them; along with the formal request of an exception to allow the IDB to perform the execution functions of the project.

10/21/2020: The Government of Mexico decided to carry out the execution of the project, through the National Institute of Ecology and Climate Change, in close technical coordination with the Ministry of Environment and Natural Resources. INECC has previous experience in the execution of an IDB GEF funded project, as it was one of the Executing Agency of the project Climate Technology Transfer Mechanisms and Networks in Latin America and the Caribbean (GEF project ID 4880). The project and its institutional arrangement were modified accordingly.

CEO Recommendation

Brief Reasoning for CEO Recommendations

This project aims to build and strengthen institutional and technical capacities in Mexico to meet enhanced transparency requirements of the Paris Agreement. Mexico ratified the Paris Agreement on September 21, 2016. Its Nationally Determined Contribution (NDC) includes an unconditional reduction of 25% of greenhouse gas (GHG) emissions below business as usual by 2030, implying an emissions peak by 2026. Conditionally, this reduction could increase to 40%. Mexico's NDC also includes an adaptation component, which prioritizes the protection of communities from adverse impacts of climate change and increased resilience of key infrastructure and ecosystems.

The project is aligned with the CBIT programming priorities to support activities that strengthen national institutions for transparency-related activities, to provide relevant tools, training, and assistance for meeting the provisions stipulated in Article 13, and to assist in improving transparency over time. Current efforts in Mexico include the definition of measures for mitigation and adaptation under the NDC, including some progress with sub-national authorities, many of which have launched Climate Change Action Plans, incorporating mitigation or adaptation targets.

This CBIT project will build on and engage with ongoing efforts to develop a platform for the tracking and reporting of actions under the SIAT-PECC (Sistema de Informacion de la Agenda de Transversalidad del Cambio Climatico). Eventually, SIAT-PECC and the platform proposed under this project (SIAT-NDC) will be fully integrated and follow the same principles in terms of transparency and the same functionalities.

The project has the following components:

- 1. Stakeholder identification and consultation for the transparency of climate action at national and subnational level.
- 2. Development of an Information System (and subsystems) of Actions for Transparency on the Nationally Determined Contribution (SIAT-NDC)
- 3. Capacity building on climate action transparency.
- 4. Knowledge exchange and dissemination of information of climate action transparency.

The project will build on a results-based loan of \$600 million with the IDB, which is supporting Mexico in improving land management to reduce emissions and vulnerability to climate change. The loan includes a component on inter-agency coordination that will strengthen the institutional capabilities of government entities for monitoring and reporting on the PECC lines of action through the development of the SIAT-PECC. It will also coordinate with ICAT support that is helping Mexico review the state of the art on MRV of mitigation and adaptation action at the sub-national level, which will inform the SIAT-NDC on the way forward for requesting data and information from sub-national entities, and GIZ support that is working on ensuring coherence of climate policies at federal and sub-national levels.

Co-financing of \$1.25 million is provided by the national government (\$200,000), IADB (\$850,000), and GIZ (\$200,000).
