Agency response ? 02 December 2024

- 1) A new LoE has been re-issued by the new Ecuador OFP. Cambodia also re-issued a new LoE which includes the footnote.
- 2) At the exception of Cambodia and Nigeria which re-issued a new LoE with the footnote, all other countries opted to send a no objection email on the use of the footnote (see attached file with no-objections from Cook Islands, Seychelles, Liberia, Panama & Maldives)
- 3) The Congo DR did not issue a new LoE nor did it confirm its agreement on the use of the footnote. Congo DR was therefore removed from the submission and substituted with Morocco.
- 4) The EAs in the MSP SECTION 1: Enabling Activity Summary have been aligned with the LoEs. The entries in the portal have been verified accordingly too. The revised MSP is appended in the road map. In the case of Maldives, the OFP mentioned that UNEP would also support them in the execution. As per GEF guidance, while the national ministries will be the EA, UNEP will definitely provide backstopping support in its capacity as IA but will not act as EA per se. In that context, no new LoEs were requested.
