Please provide justification

On exceptional basis, GEF Agencies can request a higher PPG amount with justification. The higher PPG amount in Comoros is based on bottom-up cost estimates for a PPG team of international and national consultants to develop the CEO Endorsement Request. These cost estimates, itemized by consultant, are set out below, totaling USD 91,325. Of note, the PPG costs in Comoros are elevated by two factors: • Comoros is the only Small Island Development State (SIDS) national child project in the AMP. SIDS represent a particular challenge for private sector investment in mini-grids, in particular given limitations around smaller market sizes and achieving economies of scale. To date there are few successful

models which engage the private sector. The PPG mini-grid expert will be tasked with specifically looking into this issue and developing an AMP approach for SIDS. • These estimates reflect that the geographic profile of Comoros results in high transaction costs as regards undertaking stakeholder consultations (particularly with the private sector).
