- We note that the project output on climate scenarios includes one for 2020. Please clarify as it is already the year 2020 and scenarios should not look backward.

1/21/2020:

1. Thank you for adding the submission dates for each report, as well as the other dates under Project Information. Please include the expected submission dates under the expected outcomes or outputs in Table B as well.

Please also clarify the need for three years to prepare the Biennial Update Report.

Considering that the expected completion date in 3/21/2023, it appears that the project duration of 24 months is not enough. Please change accordingly.

- 2. Considering an expected submission date of 2022, an inventory up to 2018 would be within the 4-year limit (y-4). Nevertheless, we would hope that Nicaragua can work towards developing inventories y-2. Please comment if the project, alongside the CBIT project under way, will support Nicaragua to develop inventories on an annual basis, so that it can continue to prepare and submit inventories as part of its national reports, particularly considering the modalities, procedures and guidelines adopted at COP 24.

1. Project duration has been changed to 36 months. Thank you for the additional clarification on the timelines. Comment cleared.

2. Nicaragua will continue to work on its capacity to develop inventories in a 2-year basis. Comment cleared.

Agency Response

Jan. 27 2020: Points taken

1- Submission dates have been added to the project logframe (Table B).

The county will need 3 years to prepare the BUR because it will be improving the methodology and data developed for the reference level presented in 2019. In addition, since the same team will be preparing the 4NC by December 2021, the country considers that having the BUR by December 2022 is an achievable objective. The government will prioritize the update of their NDC during 2020. The same team will be developing these processes.

The project duration is 36 months (i.e. 2020, 2021, and 2022). The project will close in March 2023.

2- Nicaragua will make every effort to develop inventories on a 2 year limit (y-2). The goal of the country is to build their capacity so that they can develop inventories on an annual basis, but this process will take some time. The CBIT will support this capacity building and will be coordinated with the proposed BUR/4NC project.

2. According to the commitments acquired by Nicaragua with the MTR Roadmap agreed during COP 24 (Katowice, Poland), the country considers that the inventory for 2016-2018 must be presented to the UNFCCC in 2022 with the first BUR. Within this context, Nicaragua's Third National Communication presented significant

qualitative and quantitative improvements regarding inventories and quantification of emission by (i) applying the IPCC 2006 guidelines, (ii) by using Landsat images to classify land use, and (iii) by using geographic information systems to process the inventory for the AFOLU sector. With these improvements, the country was able to reach a Tier 2 level. In addition, the use the IPCC software recommended by the UNCAC to prepare the GHG inventories improved the information available in the national databases.

3. Dates for climate scenarios have been corrected in Table B for 2030, 2050, and 2100.

CEO Recommendation

Brief reasoning for CEO Recommendations

This enabling activity will assist Nicaragua in the preparation of its Fourth National Communication and its First Biennial Update Report and strengthen national capacity for the implementation of the United Nations Framework Convention on Climate Change (UNFCCC).

Nicaragua submitted its Third National Communication on August 2018. In 2020, Nicaragua is focused on updating its NDC. With this project, it plans to submit its Fourth National Communication by December 2021 and its First BUR by December 2022.

The enabling activity consists of the following components:

- 1. National Circumstances and Institutional Arrangements;
- 2. National Greenhouse Gas (GHG) Inventories of 2000-2015 for 4NC and 2016-2018 for BUR;
- 3. Vulnerability and Adaptation;
- 4. National Contributions and Mitigation Actions; and
- 5. Report of the Fourth Communication, First BUR and knowledge management.

This is the first time that FAO is supporting an enabling activity under the UNFCCC. However, FAO is also supporting Nicaragua with its CBIT project, and will ensure coordination of activities under both projects.
