JS 12/11/2024 - a - The PPG is recommended for clearance.

b- During PPG, please:

- IPLCs: We note that \$1.6 million out of \$1.925 million of GBFF project financing will be allocated to actions by IPLCs. Please ensure that the entire amount reported as ?amount to support action by IPLCs [for] biodiversity? in the CEO endorsement requests corresponds to project activities supporting action by IPLCs, and that the project documentation describes the IPLCs who will benefit from the project and details their role in the project. Activities where IPLCs are mere beneficiaries should not be counted in this amount. Support to stakeholders that are not IPLCs (i.e. indigenous peoples or local communities that embody traditional lifestyles relevant for the conservation and sustainable use of biological diversity) should not be counted either. Whether the project as a whole or certain project activities support action by IPLCs could entail a number of circumstances including but not limited to: IPLCs directly receive resources through the GEF agency for execution of project components/activities; IPLCs lead the design and management of some project activities but do not manage financial resources; the project provides in-kind support to actions led by IPLCs for biodiversity, etc.

- Co-financing: While co-financing is not required in the GBFF, it is encouraged and mobilization of private sector and philantropic resources is a selection criterion. Please consolidate co-financing, especially from the private sector, as this project will support a private eco-tourism venture. The fully developed project should include a clear financial mechanism that channels part of the revenues from ecotourism to ensure long-term finance for biodiversity conservationm and clearly articulate how the GBFF grant leverage is leveraging private resources.

- Core indicators / GEBs:

Please provide in the CEO endorsement request the WDPA ID, baseline METT score and target METT score at mid-term and project end for each PA targeted by this project.

Please also capture anticipated climate co-benefits during PPG and report a target on core indicator 6 following the guidelines **and the construction of the construction of the construction buildes the transformed to the construction of the construction** benefits that are to be solod as Carbon credits that may be used as offsets should not be reported under core indicator 6. The core indicators are to capture GEBs when offsets do not generate GEBs.

The area of direct impact is currently quite limited relative to the GBFF funding request. Please consider expanding the scope and area of interventions to encompass the wider landscape surrounding the N'Zi reserve especially to address pressure from land use dynamics around the reserve and contribute to landscape connectivity.

- One of the main added-value of this project is to demonstrate a PPP and private/voluntary reserve model for replication in Cote d'Ivoire. Please include in the design a clearer pathway towards replication. It includes conducting a detailed analysis of the barriers to replication and adding key interventions to address these barriers in the design.
