CEO Recommendation

Brief reasoning for CEO Recommendations

The project objective is ?to strengthen Barbados? institutional and technological capacities to transit towards a resilient, affordable and low-carbon energy infrastructure?. The production and application of bioenergy as a low-carbon solution in Barbados? energy transition towards 100% RE faces significant barriers and challenges including finance, uptake and application as well as sustained innovation and investment.

The project scope changed after PPG assessments, with a lower focus on solar PV investments and increased focus on bioenergy development and planning. Environmental and social risks will be considered as reported by the agency through the review process, following the initial screening. Coordination will be sought with other GEF-funded initiatives in the region, for example on the opportunities related to Sargassum disposal.

Status of PPG funds has been provided, co-financing letters and corresponding funding modalities have been detailed, and geographic data was not possible to fully insert as project sites remain to be confirmed during implementation.
