

- Under section C "Eligibility Criteria" please consider adding information on the number of NCs and BURs approved so far in Turkey and their respective approval dates.
- Please consider adding information on the capacity building needs and areas of improvements identified in previous BURs as per the UNFCCC International Consultation and Analysis (ICA) process.
