III. Further guidance from STAP

1. STAP welcomes this excellent proposal that will apply mainstreaming approaches to achieve global and national biodiversity benefits in the high value conservation forests of Argentina.

2. The proposal is clear and comprehensive in its design and description, and provides a convincing case for the requested investments which address opportunities for social, cultural, economic and environmental gains. It focuses on technical and operational barriers in a targeted programme of knowledge-and capacity building initiatives; it addresses market and financial barriers to improve local communities ability to benefit from a sustainable use of NTFPs; and it addresses the institutional and regulatory weaknesses that must be strengthened to achieve its goals.

3. The project responds to several key Aichi goals and to national priorities in a well-focused programme of actions. It promises to serve as a strong mainstreaming intervention that could serve as a model for wider application.

Further guidance from STAP

4. Given the existence of several PES projects in the region, it STAP suggests that during PPG, mechanisms to coordinate activities with these and seek synergies with other mainstreaming initiatives in the area be developed.

5. Further, STAP recommends that the following GEF/STAP advisory documents be considered during the development of the full project brief - $\hat{a} \in Payments$ for Environmental Services and the Global Environment Facility $\hat{a} \in W$ wunder et al. 2010; and Environmental Certification and the Global Environmental Facility $\hat{a} \in W$ Blackman and Rivera 2010; Experimental Project designs in the Global Environment facility $\hat{a} \in W$ Ferraro 2012.
