B. PROPOSED PROJECT PREPARATION ACTIVITIES (\$)

Describe the PPG activities and justifications: The PPG will finance a series of studies needed to initiate the project as described in the PIF. This grant will cover a preliminaty valuation of ecosystem services, necessary to design compensation mechanisms envisioned for the project, which will be also characterized during the implementation of the PPG.

The PPG will provide valuable information about the current legal and regulatory framework in order to identify the laws or guidelines that will be updated to incorporate an ecosystems approach. Also it will contribute to the analysis of environmental and economic benefits, as well as the methodology needed to present a solid probabilistic impact analysis. For this purpose, the PPG includes a request for funds outside the country allocation. The environmental and economic analysis will build on the identification of technologies that optimize the use of environmental resources.

Additionally, an institutional analysis is required to evaluate the executing agency strengths, and to propose improvements. Studies will be prepared to evaluate environmental and social impacts in order to align the project to IDB and GEF safeguards. All assessments will reduce implementation risks, while providing capacity building and management tools to the executing agency. With these studies in place, the project can be implemented as planned.
