

Following up the conversation we had in Split during the meeting for the ICAM protocol, I am writing to provide you with some comments and ideas on the last draft of the COAST project we recently had the chance to read.

According to the project objectives outlined in the draft, we strongly believe that the tourism component could be enhanced by adding the following activities:

- D Identify areas where natural features (biodiversity, micro ecosystems, landscape, etc.) are providing opportunities for sustainable tourism development
- Design and implement exclusive tourism development management mechanisms that thrive and ensure the conservation of micro ecosystem areas identified
- Determine economic activities for sustainable use of natural resources in each exclusive tourism area in collaboration with tourism industry, relevant sectors (e.g. agriculture,
- fisheries, handicrafts, SMEs, etc.) and local stakeholders
- Assessing value creation potential in each exclusive tourism area, using tourism realization process (TRP - a methodology that demonstrates how a complex set of economic activities results in a tourism industry in a given destination) to create a model for replication in other areas
- Mapping the optimal supply chain network
- Developing the tourism flow management
- Implementing pilot projects in identified exclusive tourism areas
- Sharing the results of the assessments with local stakeholders and secure their ownership, fair-share and active participation in the projects

The above listed activities are part of a methodology that WWF has successfully developed in the Mediterranean in the past three years within a project on sustainable tourism. They have been specifically adapted to fit the vision and objectives of the COAST project.

We hope you will take them in due consideration in the finalization process of the project and also consider WWF, together with Sunce, as a reliable partner for their implementation in Croatia.
