Herewith we would like to express our interest and willingness to take part in UNDP/GEF project "In-situ Conservation of Kazakhstan's Mountain Agro-biodiversity".

A wide range of activities carried out by Agroinprof-Service Company correlate with the goals and objectives as set by the project; in particular, Agroinprof's priority to enhance conservation of rare and endangered medicinal plants in the mountain areas of Kazakhstan through plantation growth and harvesting.

Since 1996, Agroinprof-Service Company has provided consulting services in the field of rural development, collecting medicinal plants to cover the needs of pharmaceutical and food industries for natural floral products, and professional training activities for agricultural experts. In addition, the company seeks to create jobs for local communities living in the Ile and Dzhungar Alatau regions.

In 2002, Agroinprof-Service Company has made a US\$18,000 contribution to its action program including:

- \$5,000 – publication of awareness literature and 5 workshops in collection, drying, medicinal application and conservation of the most significant medicinal plants for people living in mountain villages;
- \$10,000 – establishment of eight plant collection teams in the mountain areas of Kazakhstan, providing 40 jobs for local people who sell the medicinal plants collected to the Company;
- \$3,000 – pilot plantations of endangered valuable medicinal species (stonecrop etc.) plants.

In 2003 and subsequent years, Agroinprof-Service Company will continue planting rare and endangered medicinal plant species including those found in the UNDP/GEF project area, collecting wild medicinal plants, and creating jobs and training activities for people living in the mountain areas of Kazakhstan in rational use of natural resources, including mountain agrobiodiversity. The total amount expected to be contributed by Agroinprof-Service Company for activities supporting the UNDP/GEF project will be US\$18,000 per year, totaling US\$108,000 for the period 2003-2008.

Therefore, by combining its efforts and coordinating activities focused on the rational use of agrobiodiversity, Agroinprof-Service Company will encourage successful implementation of the UNDP/GEF project "In-situ Conservation of Kazakhstan's Mountain Agro-biodiversity".



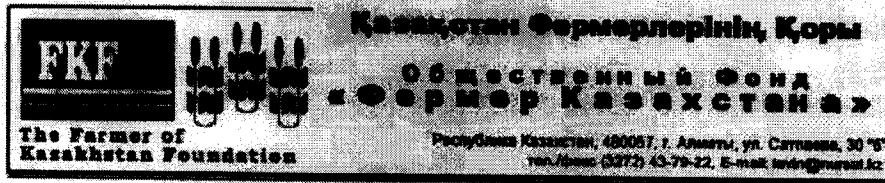

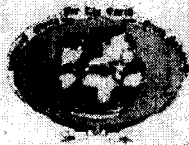

Farmer of Kazakhstan is active in several issues that relate to conservation of agrobiodiversity, including participation in legislative reform for small business support in the agrarian sector; in generation of opportunities for potential investors and creation of an independent crediting system for farmers and rural enterprises; in the dissemination of literature and assistance in organizing consulting services centres for the training and increase of the level of agricultural knowledge among farmers; and in the development and realization of projects for traditional and alternative kinds of private agricultural processing. Farmer of Kazakhstan intends to collaborate with the GEF project in the joint pursuit of these objectives.

Farmer of Kazakhstan does not have a defined budget for programs in these issue areas for the period of 2003-08. However, Farmer of Kazakhstan spent in 2001 in Almaty Oblast approximately US\$9,000, including the zone of prospective project implementation - US \$ and intends to spend at least this much during each of the next 6 years (2003-08) in areas in which it will collaborate with the GEF project. This letter serves to communicate that the non-governmental organization Green Salvation, based in Almaty, Kazakhstan, is interested in participating in the implementation of the proposed UNDP-GEF project "In-Situ Conservation of Kazakhstan's Mountain Agrobiodiversity" during that project's implementation phase.

A number of activities in the proposed GEF project correspond to the priorities and directions of Green Salvation's program. Green Salvation actively cooperates with the administration of the Ile-Alatau National Natural Park (IANNP) in the sphere of ecological education and ecological tourism. One of the main tasks of Green Salvation is promotion of the IANNP for inclusion on the list of UNESCO World Heritage Sites, as such a listing will promote conservation of the park's territorial integrity that, in turn, will radically improve the chances for conservation of mountain agrobiodiversity in Almaty Oblast and in the whole of Kazakhstan.

Green Salvation does not have a defined budget for work specific to Ile-Alatau National Natural Park, although significant work is carried out there free of charge by our volunteers. However, general expenses for the execution of specific projects (in labor and material) for the past year can be estimated at approximately US\$3,000. In the future, Green Salvation intends to continue this work at a level at least this high, so that total contributions during 2003-08 can be estimated at approximately US\$18,000.

Hereby we confirm that Baldyrgan LTD intends to cooperate with the UNDP/GEF full-scale project "In-situ Conservation of Kazakhstan's Mountain Agrobiodiversity".

The proposed GEF project supports the goals pursued by our company, particularly Component 4 of the project, which deals with the development of alternative livelihoods for the local population in the project areas related to agricultural production and processing.

Baldyrgan LTD was established in the city of Taldykorgan in 2000, and is engaged in the production of natural juices, child nutrition products, and the preservation of local food products. In 2002, Baldyrgan has expanded its operations by establishing a processing plant in the Zailiyskiy Alatau region near Almaty. The plant, using environmentally clean technologies without any synthetic mixtures, processes approximately 45,000 tons of fruits and vegetables each year, including 10,000 tons of apples. The plant was built at a cost of US\$190,000 and has created a total of 150 jobs.

In addition to this plant, Baldyrgan has also established agricultural storage stations in the Talgar and Yenbekshikazak districts. Already, approximately 1,500 peasant farmers are supplying the Baldyrgan facilities in Talgar and Yenkekshikazak.

Beginning in 2003, Baldyrgan will spend approximately another US\$160,000 per year to extend its network of storage stations in the area of the Zailiyskiy Alatau project zone. During the period of 2003-2008, total spending by Baldyrgan on these stations will be approximately US\$960,000.

Baldyrgan's policy in establishing new processing facilities and storage stations in these rural areas is to attract small-scale peasant farmers, gardeners, and summer residents to engage in fruit and vegetable production. The network of storage stations within the project areas will purchase fruits and vegetables from the local population who currently are unable to sell and expand their production/storage of fruits and vegetables, and will solve Baldyrgan's problems in accessing sufficient raw materials for its production output. In some cases, Baldyrgan will also provide financial support to farms for horticulture and market-garden development.

The total contribution of US\$960,000 from Baldyrgan will contribute to the project's goals of supporting rural agricultural producers and facilitating the conservation of wild fruit species. The increased and more stable income produced by such activities also will increase the social and economic level of the inhabitants in the project area.

From my part, I would like to assure you of our interest in being involved in the implementation of the project on conservation of mountain agrobiodiversity in Kazakhstan.

Hereby we confirm that the corporate fund Kazakhstan Community Loan Fund (KCLF) based in Kazakhstan is willing and intends to cooperate with the UNDP/GEF full-scale project “In-situ Conservation of Kazakhstan's Mountain Agrobiodiversity”.

KCLF was established in 1997 with the support of ACDI/VOCA and sponsored by USAID and Kazakhstan-Soros Foundation grants to implement microcredit programs in Kazakhstan. Presently, KCLF is a local Kazakh NGO with branches in Almaty, Taldykorgan and Shymkent, with legal status and a license issued by the National Bank to operate as a non-banking financial institution. Through its fifth period of operation, KCLF has gained acknowledgement throughout Kazakhstan and has a reputable image for both domestic and foreign investment support.

KCLF provides small loans to increase turnover capital and procure fixed assets, and provides technical support to clients through its credit officers. KCLF provides group crediting through a group guaranty system as well as individual crediting (since 2001) in the US\$1,000-5,000 range. In 2001, KCLF administered credit portfolio with a risk rate of under 2% and provided 11,000 loans for a total amount of US\$3,000,000. KCLF's revenues are invested in loan capital and corporate development. A sustainable flow of service revenues and additional capitalizations (including through international institutions) has enabled KCLF to grow and develop the capacity to meet client's needs at increasingly complex levels.

The proposed GEF project supports the goals pursued by the KCLF. KCLF actively works with small-scale businessmen dealing with agricultural products and services, of whom 80% are women, and KCLF is eager to expand through microcredits for farmers and small businesses dealing with agricultural production. Given this priority, KCLF plans to open a number of additional branches and offices within the next 3 years, including offices in Talgar and Sarkand (sites of the UNDP/GEF project). KCLF will coordinate its efforts with the above-mentioned project to support and provide loans for alternative livelihoods through its own financial resources and loans.

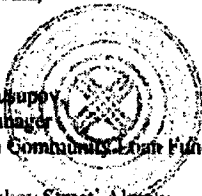

Настоящим уведомляем Вас, что ТОО «Компания «Жибек Жолы», созданная в Казахстане (г. Алматы) и действующая в соответствии с Меморандумом о сотрудничестве между Компанией «Жибек Жолы» и ПРООН в Казахстане, заключенным 21 февраля 2000 года, подтверждает свою готовность участвовать в реализации проекта Правительства Республики Казахстан – ГЭФ «Сохранение In situ горного агробиоразнообразия в Казахстане» с демонстрацией на двух участках.

Компания «Жибек Жолы» – исполнитель Международной и Государственной программы по Возрождению Великого Шелкового пути на казахстанском участке, на протяжении последних лет сотрудничает с Иле-Алатауским Национальным парком по вопросам осуществления международного туризма, а также организует туристские маршруты в зоне Джунгарского Алатау, активно занимается вопросами создания в этих зонах туристской инфраструктуры. Предлагаемый проект поддерживает идеи, которые преследует наша компания, а именно: сохранение уникальных природных комплексов и глобально значимых видов агробиоразнообразия, развитие в этой зоне экологического и приключенческого туризма, туризма с лечебным фактором, а также альтернативных видов деятельности местного населения, связанных с туристским бизнесом.

Компания уже потратила в этих регионах порядка 900 тыс. долларов США на организацию туристических маршрутов, выкуп земельных участков для строительства гостевых домов, кемпингов, туристско-этнографического комплекса «Талькит» в районе г.Талпарт – одного из первоочередных проектов Госпрограммы, стоимостью 4,7 млн. долларов США, проведение проектно-исследовательских работ, подготовку бизнес-планов, рекламу и пр.

Также, в Алакольском районе были проведены поисково-разведочные работы месторождения бентонитовых глин, получена геологический отряд земли, проведены клинические испытания производства медицинского препарата «Сместитт Ю» – аналога французской «Сместитт», химический анализ



сырья, получены патенты, свидетельства, сертификаты и пр. необходимые документы для производства препарата и многое другое. Подготовлен бизнес-план по организации производства «Смектита К» стоимостью 200 тыс. долларов США. Общая сумма вложенных компанией средств на указанные цели составляет свыше 300 тыс. долларов США.

В 2003-2008 годах в зоне реализации и по направлению сотрудничества проект ГЭФ «Жибек Жолы» намерен направить финансовых средств в объеме порядка 800 тыс. долларов США на следующие цели:

1. Организация производства лекарственного препарата «Смектит К» в Алакольской районе – 200 тыс. долларов США.
2. Дальнейшее участие в развитии местной инфраструктуры и индустрии туризма на территориях Джунгарского и Иле-Алатауского Национальных парков и прилегающих к ним территориях – 600 тыс. долларов США.

Осуществление этих проектов позволит:

- предоставить дополнительные рабочие места местным жителям;
- способствовать дальнейшему созданию контролируемого экотуризма, туризма с лечебным фактором, как экономической основы эффективного использования природного потенциала без ущерба для окружающей среды;
- участвовать в организации на местах регулируемой хозяйственной деятельности, подготовке гидов-экскурсоводов, рейнджеров и пр.
- принимать участие в проведении природоохранных мероприятий.

О поддержке проекта "Сохранение in-situ
горного агробиоразнообразия в Казахстане"

В связи с завершением работ группой Экза Б. KAZIMOVAN проекта
"Сохранение in-situ горного агробиоразнообразия в Казахстане", Алматынской
областной акимат рассмотрел финальную версию проектного документа,
одобряет его и готов содействовать успешной реализации на двух проектных
территориях в Джунгарском и Замайском Алатау.

Одновременно с этим представляю официальное подтверждение акимата
областного Акимата, акимата Алматынского, Сарыаркинского, Ембильно-Кызылординского
и Талгарского районов и прилегающих или прелесть третьих сторон в зону
реализации проекта, которые будут способствовать успешному решению его
целей и задач.

Ежегодно в регионе Алматынской области планируется использовать до 500 000
долларов США на поддержку малого бизнеса и крестьянских хозяйств, включая
развитие рынка, рыночных и кооперативных проектов, развитие программ
обучения и помощи сельскохозяйственному сектору и программ кредитования.
Из этой суммы 50 000 долларов США выделено будет направлено на
территорию двух участков проекта. В общей сложности за период 2003-2008
годы на поддержку альтернативных экономических видов деятельности в рамках
проекта ГЭФ/ПРООН будет выделено 300 000 долларов США.

В заключение хотелось бы добавить, что указанный проект ГЭФ/ПРООН и

способствовать решению приоритетных задач этого развития.
