Madagascar submitted the its Monograph on Biodiversity, and its first National Report in 1997(ANGAP, National Biodiversity Unit, ONE / PNUE). The CHM was established at Office Nationale de l'Environment (ONE) at the same time. Furthermore, the support provided under the GEF/UNDP project component of the Madagascar Support Programme II was instrumental in developing the National Biodiversity Strategy and Action Plan.

Project objectives of the current request

The main objective of the add-on request is to assist the Government of Madagascar in undertaking consultations towards its second national report to be submitted to the Conference of the Parties (COP) in accordance with the COP decision V/19 (National Reporting). Although the May 2001 deadline for submission of the Second National Report has been missed, the report will be submitted at the earliest possible. The Government of Madagascar and UNDP/GEF are satisfied this add-on request complies fully with the GEF operational criteria for additional funding of Enabling Activities.

The second national report will:

- cover the progress made in different areas concerning the protection of biodiversity,
- provide reasons for weaknesses,
- propose measures to improve the constraints with an estimation of time.

The second national report will follow the format recommended by COP in decision V/19.

Project Implementation and Institutional Framework

The project will be implemented by ANGAP; facilitators engaged through co-financing from ANGAP will be selected to lead working groups consisting of experts, government staff, and other stakeholders. Information will be solicited from key government agencies and other national agencies. A draft report will be discussed within a national workshop before finalization by a drafting committee and adoption by a second national workshop.
