### C. PROPOSED PROJECT PREPARATION ACTIVITIES (\$)

Describe the PPG activities and justifications:

1. *Initial consultations* nationally and regionally – the proposed international as well as national project teams did not had opportunity to meet until now. PPG funds will be used to confirm roles and responsibilities for national EAs & technical partners on both the project design process, as well as anticipated national roles in the implementation of the IAS project, and reach agreement on national priorities & workplans (co-financed). Agreement has to be reached on type of forest pilots for testing IAS control and management, whilst maximizing GEB. Additionally, prospective project partners will be brought into discussions on specific interests, roles and responsibilities towards the proposed Regional Forest IAS Strategy SE Asia.

2. *Regional and national baseline assessments and analysis of IAS*, have to be conducted regarding key species to focus on in the project (also in its regional context; issue of animal and/or plant IAS), their impacts, driver/pathways, related policies, regulations, institutions, as well as associated barriers to a successful national IASS programs. The PPG team will therefore begin by analyzing available materials regarding regional & national invasive species broadly and national forest invasive species specifically.

This will include a.o. information on the following:

- numbers and types of invasive species in the countries & region of major impact to forest habitats and forest related production systems;

- identification of major drivers and pathways leading to introduction and spread of invasives;

- existing institutional, legal and policy aspects, quarantine systems available, enforcement, etc.;

- climate change risks and vulnerabilities;

- previous and ongoing donor support;

- threats, causes and associated barriers to national and regional IAS programs.

- agreement and application of pilot selection criteria, including BD values, costs effective programming, feasibility of anticipated results). Conduct baseline assessment pilot sites.

Information and analysis will be extracted and presented in a manner that matches GEF programming requirements, i.e., according to thematic areas such as threats to achieving SFM, socio-economic context, institutional, capacity & financial barriers, biodiversity (GEB( significance) of pilot sites for selection, etc. Resulting needs & gaps analysis and draft summaries will be used for confirming the project framework. Importantly this analysis should guide prioritization of specific country program elements and outcomes as well as match available BD RAF allocations set out in the PIF. Agreement will be reached on these through broad consultations in the four countries, a regional workshop, as well as where useful, site visits.

3. *National and regional Awareness, information services and social marketing program design.* Building national awareness on IAS early in the FSP is very important to enable many of the other outcomes and outputs, as well as to work early in the process towards sustainability of the national IAS programs e.g. in the field of costs recovery mechanisms. The basic design of this has to be conducted during the PPG and as such as specialist in social marketing has to be contracted assist the NEA as well as Int EAs with this, including on effective ways of collating and using the available information globally on IAS during the FSP to the benefit of effective IAS prevention, control and management. PPG funds will also be used to establish the baseline awareness levels with government line agencies, decision makers and locally affected communities.

4. *Institutional capacity & stakeholder assessments*. No project can properly be designed without a good insight in institutional and human resources needs. PPG funds will be applied to conduct an initial training needs assessment, as well as identification of specific technology or equipment needs to support effective IAS programs in the four countries. It will also design the stakeholder engagement plan, specifically with regards running of pilots in the forested areas. Additionally it will conduct national and regional stakeholder workshops to prioritize IAS themes most relevant to target countries; and (iii) based on these, identify what (data, information, research, outreach and civil society) partner organizations and governments should be involved as executing agencies.

### 5. Project (proposal) preparation and co-finance mobilization.

This component will involve compiling, analyzing and consolidating the findings into a project logframe, workplan, budged including co-finance, staffing plan, and GEF & UNEP project proposal documents.

6. Design of project M&E plan.

It is a GEF and UNEP requirement to establish a fully-fledged M&E Plan including both progress as well as performance impact monitoring, MTR as well as Terminal Evaluation
