

A Proposal for Accessing GEF Funds for the Clearing house Mechanism (CHM) for Sri Lanka.

Background:

Sri Lanka is a partner to the United Nations Convention on Biological Diversity. The Convention entered into force, at a global level on 29 December 1993, while Sri Lanka ratified the Convention on 23 March 1994. Therefore, it is obligatory in our part to implement the provision and decision taken by the Conference of Parties of the Convention on Biological Diversity.

The Articles 17 and 18 of the Convention clearly specify the role of the Clearing House Mechanism to promote the technical and scientific cooperation. Sri Lanka has already carried out many of the activities associated with the implementation of Article 6b with support from a Full GEF project SRI/92/G31 entitled "Wildlife Conservation and Protected Areas Management". Therefore, rather than requesting a full EA, Sri Lanka is simply requesting initial support for basic implementation of the CHM provision.

Goal:

The ultimate goal of this project is to strengthen the capacity of the National Clearing House Mechanism.

Objective:

- 1) To facilitate exchange of information;
- 2) and, To facilitate scientific and technical cooperation.
