B. PROPOSED PROJECT PREPARATION ACTIVITIES (\$)

Describe the PPG activities and justifications:

The PPG funds will be used primarily to ensure that project actions will meet GEF objectives to build on baseline actions to significantly enhance global environmental benefits. Inputs will be provided to design the project based on past investments and lessons learnt- including GEF investments in the country and globally. During the project preparation, detailed baselines actions, GEF increments and cofunded activities will be oulined to best meet the project objective. The monitoring and evaluation framework for the project actions will also be details. The cost effectiveness, sustainability and replicability of the proposed actions will be examined and the best optiosn will be selected. The proposed project outcomes and outputs, presented in the PIF, will be further defined and refined, as necessary, with stakeholders' inputs - including relevant government agencies, academia, private sector, the UN agencies, international and national NGOs and donors. The following describes key activities that will be undertaken through PPG and cofunding. These will be then presented as final full proposal to the GEF as the CEO Endorsement Template and related biodiversity tracking tool (METT) for project sites.

The following steps will be undertaken during the PPG phase:

A. Establishment of consultative mechanisms for full project development.

This will be entirely co-funded by the government and UNDP. The main actions will include:

- 1. Establishment of institutional arrangements for PPG, with strong involvement of key government partners
- 2. Mobilization of government stakeholders from national to local levels and other partners to develop the full project document
- 3. Recruitment of consultants, as identified
- 4. Mobilization and confirmation of co-funding for project
- 5. Planning and facilitation of stakeholder consultations
- 6. Review and finalization of project document and CEO Endorsement Template

The actions described below will be carried out by teams of government and UNDP staff, national/international consultants under the guidance and supervision of the national implementing partner, with technical inputs form UNDP. The purpose of this exercise is to build on best available knowledge in Viet

Nam and globally to secure biodiversity conservation benefits in a cost-effective, replicable and sustainable manner. The draft reports of these consultants will be reviewed by the national focal point and UNDP. The reports will be incorporated in the Full Size Project (FSP) document. Lessons learnt during PPG implementation will be collated, analysed and applied to the design of the FSP.

- B. Actions to be undertaken with respect to Project Component 1: Establishment of new wetland protected areas and relevant systemic capacities for their effective management
- 1. MONRE will undertake its own self capacity needs assessment/ performance assessment in relation to their mandate to promote wetland conservation nationally, to identify key areas of improvement
- 2. The project site selection will be confirmed taking into account GEB, social feasibility and other parameters. The criteria for site selection are: biogeographic representation; global environmental significance; socio-economic feasibility, and socio-cultural diversity (sites selected in different socio cultural landscapes, to build experience working in different areas. A proposed boundary delineation at least 2 new wetland PAs will be designed, based on assessment of biodiversity values and other criteria, and clarified with local stakeholders
- 3. Assements of biodiversity values and other ecosystem services from the proposed wetland PAs will be undertaken to aid zonation of the PAs
- 4. Stakeholders and institutional asssessment will be undertaken for demonstration sites to work out institutional set-up for effective PA management
- 5. Threats to wetlands, mitigation measures, and costs for them as well as monitoring and evaluation mechanisms will be worked out, with stakeholder involvement. Site level baseline METT will be developed, as well as scores for capacities for PA management institution.
- 6. Options for sustainable financing of new wetland protected areas will be identified -including PES at sites, and any other national level financing mechanisms
- C. Actions to be undertaken with respect to Project Component 2: Integrity of wetland PAs are secured within the wider wetland connected landscapes
- 1. Identification of lanscape within which the new PAs are located (under component 1) that need to be better managed to ensure integrity of the new PAs (including particular habitats in the landscape that are important for critical species) and baseline of work being undertaken
- 2. Identification of key stakeholders in the landscape, their roles, responsibilities and actions that promote effective landscape management or hinder it, and consultations with them (individually and/or collectively) to plan actions that enhance their positive influence on the landscape including identification of incentives for positive actions (including opportunities to mainstream such action plans in their own plans and programmes)
- 3. Agreed mechanism for monitoring the actions, impacts and status of the landscape
- 4. Community involvement plan (for CBNRM) to enhance their roles and responsibilities with strong focus on gender and indigenous issues and economic faesibility of alternative livelihoods to offset livelihood threats to biodiversity conservation
- D. Project institutional arrangements and M&E system development
- 1. Under this activity, institutional arrangements will be developed, partnerships will be strengthened and co-funding commitments from key stakeholders will identified for the implementation of this project and for developing long-term institutional/partnership mechanism for financing wetland PAs and landscapes to achieve global biodiversity conservation objectives. Risks to project and their mitigation measures will also be outlined, as well as M&E mechanisms for the project and staffing needs.
