B. PROPOSED PROJECT PREPARATION ACTIVITIES (\$)

Describe PPG activities and justification:

The purpose of the proposed PPG exercise is prepare the required documentation for the proposed GEF project of Cuba on clean energy technologies for rural areas (CleanEnerg-Cuba). This will be done through the performance of specific project preparation activities that are intended for the: (i) collection and processing of the necessary technical, financial and other input information needed to design the activities of the proposed GEF Project that is focused on the integrated production of biomass energy by agriculture and livestock establishments in Cuba; and (ii) establishment of the project implementation and management arrangements, building on the good working relations with stakeholders; identification of the envisaged investment pilots and consolidation of the project co-financing. The activities under the PPG exercise will be performed by a team of national experts and one international bio-energy expert, under guidance of an international consultant, who will be responsible for the delivery of the full size project documentation to UNDP for submission to GEF. The cost for the project preparation activities will be paid with the requested PPG. Other costs items that will paid for by the Government of Cuba and UNDP as co-financing include: (i) Meetings and negotiations with stakeholders; (ii) Consolidation of external co-financing (particularly for the investment-related activities); and, (iii) Project Office facilities, local transport and project management.

The PPG exercise is expected to be completed over a period of six months. The expected outputs are:

- (a) Detailed description of project activities, outputs and costs for all components
- (b) Completed preliminary assessments of bio-energy potential in the primary agriculture and livestock sectors in Cuba
- (c) Completed preliminary assessment of economic, social and environmental aspects of bio-energy generation
- (d) Detailed mapping of actors and support organizations at the municipal, provincial and national level
- (e) Report on the applicable bio-energy technologies and integrated food/energy production modalities that can be applied and promoted in the Project
- (f) Project Strategic Results Framework (log frame) that describe the project goal, objective, outcomes and

- outputs, including performance indicators, means of verification, and assumptions
- (g) Defined baseline and estimated environmental benefits delivered by the Project, as well as the strategy/approach to realize the potential environmental benefits
- (h) Quantified budget for the project
- (i) Project institutional arrangements and implementation plan, including coordination with other initiatives and project counterparts
- (j) Supportive documents with assessment of barriers and capacity gaps
- (k) Description of envisaged pilot investments and hardware requirements
- (1) Confirmed co-funding mechanisms and sources, and co-financing letters
