7. Project linkage to national priorities, action plans, and programmes:

- Environment protection is an important national concern and priority in Iran. Article 5 of the constitution requires all development activities to be in harmony with the environment. The "Environment Protection Act" and the "Clean Air Act" strongly call for preventive and remedial measures for the protection and rehabilitation of environment. The on-going National Development plan incorporates a number of environmental objectives.
- Over one third of Iran is desertland. Overgrazing and removal of vegetation cover for fuel has set into motion a process of expanded desertification which is threatening cities, villages, roads and farmland. This process considerably reduces the carbon sink capacity of the land. Faced with the threat, the Government has allocated considerable investment to initiate desertification programmes. The UNDP has been co-operating with the Government in a number of initiatives that aim at sustainable development of land and water resources with emphasis on desert combat. UN is also supporting the UNFCCC Enabling Activities which, inter alia,, aims to develop a mitigation strategy to counter negative impacts of the climate change on the desertland.
- Hosseinabad is located in south Khorasan on the margins of the Central Desert. The area has been home to thousand of Afghan refugees who fled the conflict and economic hardship in Afghanistan. The influx of refugees increased the pressure on the already fragile ecosystem. Most of the vegetation cover has been eroded to provide for forage and fuel. The Government has identified the area as high priority region for its desertification combat activities.
- 8. GEF national operational focal point and date of country endorsement: Ministry of Foreign Affairs, 7th of January 1997.

9. Project rationale and objectives:

The project will be a 'model' initiative for the dual objectives of offsetting biotic carbon and promotion of sustainable livelihood through a participatory approach in desert combat. It will sequester carbon, at a very high level, in the desertified lands of Hosseinabad through the establishment of a hand planted Haloxylon forest. All activities will be carried out by the local civil societies. The Haloxylon forests will store carbon at levels justifiable by the STR criteria-Footnote 25, Chapter 3. The forests will also remove the threat to the existing farmland and will rehabilitate the desertified farmland. Increased farm production will provide for an improved livelihood of the poor farmers and refugees in the area, thus reducing the fuel wood demand, which is presently the cheapest form of fuel. The project will be later used as a model initiative for replication throughout Iran. As such the potential carbon sequestration is much higher than what can be expected from the project. Baseline activities will be supported by the Government including the supply of seeds and seedlings, nursery building and watering equipment. Government will also provide technical personnel.

10. Expected outcomes:

As a result of implementing the project 9,700 hectare (ha) of desertified land will be converted to a grazing forest land. The potential stored carbon in roots and stems will be 8.2-13.8 tonnes/ha. The arid conditions of the proposed site as well as the stability of the sink would affect a slow recycle of carbon (in excess of 100 years). The project will increase the villagers income by increasing the forage production from the present 50-60 kg/ha to 300-400 kg/ha and by providing land for additional farming activities. It will also reduce the threat of the expanding desert and will be an incentive for the farmers to remain in the area. The project will enhance the indigenous capacity in environment rehabilitation and can be disseminated to and replicated in other desertland areas of Iran.

11. Planned activities to achieve outcomes:

- Plantation of 9,700 hectares with seedling of Haloxylon Persicum, caligonum and Artiplex through
 participation of the villagers as organized in civil societies. The Plantation ratio is 80%, 10% and 10%
 respectively.
- Capacity building through training and extension activities and promotion of environmental awareness,
 particularly amongst the youth and women. Capacity building will address different types of soil/terrain
 conditions and will target the ultimate objective of enabling the nationals to train others and disseminate the
 know how gained.
- Workshops to draw attention to the sustainable development at nature of the project, especially through careful
 monitoring of project activities of the initial stages.
- Information sharing events and activities with other rural communities.

12. Stakeholders involved in project:

The local branches of the Forest and Rangeland Organization, Nomadic Affairs Organization and local communities including semi nomadic herders. The Forest and Rangeland Organization (FRO) operates under the auspices of the Ministry for Construction Crusade.

In addition, this PDF A needs to distinguish baseline activities from incremental activities, and clarify the methodology for estimating unit abatement cost in view of the recent relevant initiatives under the targeted research studies. The output of the mission is a finalized GEF Medium-Size Project brief and project document to submit for GEF financing in carbon sequestration in the desertified rangelands of Hosseinabad. The PDF A will cover the costs for
