Agricultural non-point source pollution control technology demonstration project

To: Foreign Economic Division of Shanghai Municipality Finance Department

The implementation of the “Agricultural non-point source pollution control technology demonstration project” by the Shanghai Municipality Agricultural Technology Extension Service Center started in May 2009 and it will be completed in May 2011. The total investment of the project is 132.93 million RMB Yuan (2 years), of which, the World Bank provides 6.05 million RMB Yuan (RMB equivalent), accounting for 4.5% of the total investment; the domestic counterpart funding is 126.875 million RMB Yuan, accounting for 95.5% of the total investment.

The composition of the above-mentioned counterpart funding will be respectively: special subsidy of the municipality finance for commodity organic fertilizers, special-purpose fertilizer for formula fertilizer application based on soil analysis, green prevention and control for pests and pesticides, accounting for 35.1% of the total investment; 80.32 million RMB Yuan of equity of the producers for purchasing subsidized fertilizers and pesticides, accounting for 60.4%, of which, the subsidy of the Municipality Finance has been incorporated in the special budget of the current year of 2009 and we will continue to request its inclusion in the annual financial budget in 2010 in line with the project plan. As the project implementer, the Shanghai Municipality Agricultural Technology Extension Service Center will be responsible for the corresponding counterpart funding allocation and for ensuring that the earmarked funds will be used solely for the approved purposes.

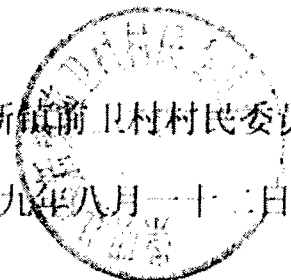

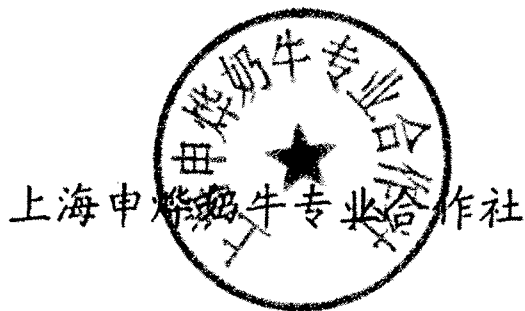
