Further to the discussions held with the World Bank Mission that visited Kenya in May 2003, I would like to assure you that the government of Kenya fully endorses the proposed Western Indian Ocean Marine Electronic Highway and Coastal and Marine Contamination Prevention Project.

As the Hon. Minister for Environment, Natural Resources and Wildlife, Dr. Newton Kulundu mentioned to the visiting mission, Kenya was requested to lead the coordination of Coastal and Marine Programmes under the Environment Component of the New Partnership for Africa's

Development (NEPAD) and will in this regard be the clearing house for NEPAD-related projects on the marine environment. 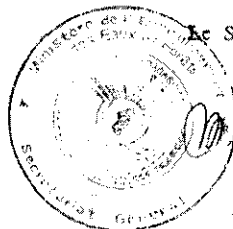

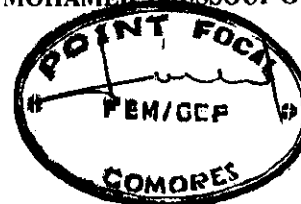

**RE: WESTERN INDIAN OCEAN MARINE HIGHWAY AND COASTAL AND MARINE CONTAMINATION PREVENTION PROJECT**

This letter is to confirm that I believe that South Africa would be interested in participating in the above-mentioned project.

Although South Africa has had oil spill contingency plans in place (together with a Coastal Sensitivity Atlas) since the mid - 1980's, we are less well prepared to deal with spills of, for example, hazardous chemicals. Moreover, the oil spill plans are currently being updated to take account of new Local Government structures as well as other more recent developments. The sensitivity maps are also being put into digital format.

In light of the number of accidents along our coastline, we also believe that a lot more needs to be done on the prevention side. To this end, the DEA & T, in consultation with SAMSA and other interested parties, is currently also in the process of developing a proposal for submission to the IMO for the establishment of a "Particularly Sensitive Sea Area" around our coastline.

In addition to the above, there are a number of other reasons which would support our participation in the project:

1. Oil spills along the East African coastline are highly likely to impact on our coastline, because of the prevailing current patterns. It is therefore to our advantage to support the development of capacity to both prevent and respond to oil spills in our neighbouring countries.
2. We have, in fact, been involved in a similar project which involved just the Indian Ocean Islands, where we have provided training in oil spill response to some 60

officials from the island states. This new project follows on from, and builds on that project.

3. The National Assembly, on the 5<sup>th</sup> November, 2002, approved a recommendation for South Africa's accession to the Nairobi Convention and its Protocol. The latter commits us to co-operation around maritime emergencies.

Unfortunately though, both our Minister and the Director-General - who is the Focal Point for GEF projects in South Africa - are away on leave until mid-January. It will therefore not be possible for me to arrange a formal letter of endorsement of the project until after that date.
