III. Further guidance from STAP

STAP welcomes this proposal, and is broadly supportive of the small grants program (SGP) overall. The SGP is uniquely placed to test innovative actions which address multi-focal area (MFA) challenges in a local setting, and to combine the delivery of global environmental benefits with actions to reduce poverty and promote local livelihoods. STAP also broadly supports the selection of objectives from the GEF-5 Focal Area Strategies, as these are designed to bring global and local benefits into alignment.

For all UNDP-SGP projects, STAP has the following overall recommendations:

Attention to the GEF Focal Area 'learning objectives' is highly relevant to the selection of individual small grant projects. In particular, this allows for additional opportunities to further evaluate the effectiveness of common approaches such as product certification, community forest management among others.

STAP understands that the SGP tends to be treated very much as a stand-alone project in each UNDP Country Office, often weakly integrated with other national and local-level multi-focal area initiatives. As such, STAP recommends attention be given as to how the SGP will be integrated institutionally in-country so that the SGP's outputs support multiple objectives, influence other activities, and where possible are sustained over the long term.

STAP would recommend that the contribution of these projects to the development of human and institutional capital and improved knowledge management at national level be further elaborated wherever possible. Additionally, these projects are uniquely placed to improve learning and knowledge management at the national level, and contribute directly to our understanding of the delivery of global environmental benefits and sustainable development objectives.

Finally, STAP encourages that each SGP defines explicitly the focal area-specific baselines, specify the multiple benefits, including indicators for each benefit to track the global environmental outcomes.
