The resulting MSP will be aimed at (i) building legal, regulatory and institutional framework for the implementation of the Stockholm Convention; (ii) achieving synergies and coordination among activities relevant to global chemical and waste management agreements, specifically the Stockholm, Rotterdam and Basel Conventions; and (iii) implementing practical measures to facilitate an integrated national approach for chemicals and wastes management.

- setting up institutional capacities/structures and strengthening the interactions amongst concerned Ministries and Departments aimed at revealing the principal sources of POPs contamination, reducing POPs releases and eliminating the most hazardous sources, investigating environmental contamination by POPs and to taking joint action for preventing adverse effects on human health and the environment;
- carrying out wide information and awareness-raising activities on POPs to develop and establish a POPs information system; and
- extending and strengthening international cooperation and collaboration relevant to POPs management, information exchange of data obtained as a result of R&D (research and technical design developments), monitoring studies, BAT and BEP.

Under the Project fulfilment the following activities were undertaken:

- organization and holding the Workshop on POPs Project Cycle Management and Logical Framework Approach;

- development of draft MSP Project on “Capacity building for implementation of the NIP for the Stockholm Convention on POPs”.
